Reminders from the Code Enforcement Officer

When you are planning on building, or doing other projects plan on applying for a permit well in advance. Pay particular attention to the plot plan and follow the sample one in the permit application instructions. In certain situations a Planning Board Conditional Use Permit may be required and may take 60 days. Deeds <u>must</u> accompany all Permit Applications and are available at the Sagadahoc Courthouse Registry of Deeds for \$2. If the lot is not in the Shoreland Zone or Resource Protection Zone, a 200 square foot accessory structure or 100 square foot addition can be built without a permit, however in both cases the setback requirements must be met. A few other things that need a permit are Driveways, Timber Harvesting, and Land Clearing, Filling, Grading, or other Earth-moving activity Don't start a job without a permit or at least give the CEO a call to ask about the requirements.


The Town of Arrowsic and the State of Maine have strict regulations governing Timber Harvesting and Clearing for permitted uses in the Shoreland (within 250 feet of Mean High Tide of any river or stream or any salt water body or wetland.) The 100 foot buffer strip, immediately along the shore, has more specific guidelines than the remaining 150 feet of Shoreland, If in doubt call.

The Resource Protection District is a more complex area and is too lengthy to include here. If you are planning on cutting any trees in either one of these districts call the CEO a week or two in advance so that I can go over the regulations with you. If you don't know what district you are in call the CEO.

The purpose of this article is to insure that the information is available so that costly errors, like Stop Work Orders, Fines, and the replanting of trees, can be prevented. I can be reached at 443-2114 until July I, leave a message if I am not there, and I will return your call.

I will complete my time as Codes Officer and Local Plumbing Inspector at the end of June 2002 and Michael Kriendler will be appointed to the job. I have enjoyed working with the other Arrowsic Officials and all of the People of Arrowsic that I have had any opportunity to meet with, thanks.


