

## ARROWSIC SELECTMEN'S MEETING MINUTES

NOVEMBER 24, 2014

### **WARANT AND TREASURERS REPORT:**

Warrant #10 (\$1,610.81) was reviewed and approved by the Selectmen.

### **MINUTES:**

Minutes of 11/10/2014 were reviewed and approved by the Selectmen.

### **TOWN CLERK'S REPORT:**

Linda reported that she and Amy Smith are progressing in getting the election closed. There have been delays at the State level that have caused delays at the local level. She also reported that the Town Office will be closed on Friday November 28<sup>th</sup> (the day following Thanksgiving).

### **KAREN ROBBINS WITH SOME ESTIMATES FOR FIRE DEPARTMENT PAD (6:30PM):**

Karen has been looking into getting bids for the fire station apron. She presented a bid from John Schadler of \$10,050.00 to the board. The site prep involves: compacting, adding 2" of foam to level the site, rebar to the same specs as the inside of the fire barn (control joints gives flexibility in cement), soft curves need to be caulked and to seal the slab 30 days after it is cured. Also, for additional materials as needed to have matched surfaces for a 6" slab. Both Karen and John recommend waiting until spring (after the roads are unposted). Karen has donated her time in coordinating this project. The Selectmen thanked Karen for her generosity.

The board will now investigate the best way to raise the funds for the project since the proposal came in so much higher than budgeted.

### **ASSESSING SUPPLEMENTALS AND ABATEMENTS:**

Bill made a motion to approve and sign the Tax Supplements and Abatements to Celia Carlton's accounts due to assessor error. Sukey seconded, all approved.

### **INQUIRY ABOUT GIS SERVICES:**

Aaron Wester of CAI Technologies emailed the town and offered his services for a mapping project. Sukey will let him know that we have no need for these services.

### **VIOLATION UPDATES:**

No new information at this time.

### **ARROWSIC PATTEN FREE LIBRARY REPRESENTATIVE APPOINTMENT:**

Barbara Boyce called Roger Heard and let him know that Arrowsic needs a volunteer for the position of Library Representative. Sukey has volunteered to the representative. Bill agreed to recommend her to the Patton Board.

**CONSIDERATION OF SPIRIT AWARD FOR 2014:**

Spirit of America Awards wants Arrowsic to participate. The Selectmen do not see the need to participate since we can recognize residents who contribute to the Town at Town Meeting

Sukey reported that we are up to date with proper notification of RC Rogers insurance.

The 200 Copier is currently on Craig's List, we have not received any offers. Bill will update the ad to say that it does need repair and that we are asking \$25 for it.
