UPDATE FROM FIRE

PROTECTION COMMITTEE

Since the last **Arrow**, much has been accomplished in bringing the issue of contracting fire service to a meaningful vote for the Town. The committee and Neil Courtney (of Maine Fire Training and Education, hired by the Town of Arrowsic) met in February with the Fire Committees, Fire Chiefs and Selectmen from the towns of Arrowsic, Woolwich, Georgetown and Bath.

We discussed the situation Arrowsic faces with costs and volunteers regarding our fire department and future fire protection for the Town. We asked the towns represented if they would be willing to discuss this further. Georgetown and Bath felt that given their current situation, they would not be able to adequately cover Arrowsic given the liability questions and costs involved. Woolwich's Fire Chief Don Forbes and the Woolwich Fire Commission agreed to further discuss the issue.

Arrowsic Selectmen and the Arrowsic Fire Prevention Committee met again with the Woolwich Fire Commission in mid-April. Woolwich had set up 5 committees to deal with the issues of insurance, mutual-aid, a fire contract, operating procedures and dispatching. They were then in the middle of researching those areas and their impact on the two towns if we agreed on a contract.

On April 28, the Woolwich Fire Department firefighters and the Woolwich Fire Committee voted to go ahead with the project and recommend to their town that they negotiate a contract with Arrowsic if Arrowsic so desires. After Arrowsic settles the issue at our Town Meeting June 19, Woolwich Selectmen will take up the issue.

The Arrowsic Fire Prevention Committee feels that contracting our fire service is in the best interests of the Town. The cost to upgrade our Volunteer Fire Department coupled with the lack of volunteers from our town has brought us to this position. The AVFD is using equipment that is inadequate and creates a danger for the firefighters and a legal liability for the Town and its fire chief.

A full discussion of the issue is available in the Town Warrant this year with reports by the Fire Prevention Committee and by Neil Courtney of Maine Fire Training and Safety. If anyone wants to see the reports before the Warrant becomes available, call Greg Guckenburg or Milly Stafford. A public hearing with Neil Courtney and Woolwich Fire Chief Don Forbes will be held Wednesday, June 5 at 7:00pm at the Arrowsic Town Hall to answer questions.

We are strongly opposed to tarring any portion of Bald Head Road.

— Money could be better spent towards emergency services.

— It would be too costly.

— It's unnecessary; the existing dirt road is in good condition.

— It's a safety issue. Cars go too fast now — a tarred road would be an invitation for a speedway. Anyone who walks on the road would be in even greater danger of getting hit. Walking with dogs would be very unsafe.

An Open Letter from Selectman Pat Harcourt

As I approach the end of my term as a selectman of Arrowsic, I want to share some of my insights.

Since my background is in business and management, I think of the town of

Arrowsic as a corporation. The voters are the board of directors. Each year at Town Meeting we choose new managers for our town. If you were on a corporate board of directors, you would make these choices very carefully, because you would be placing your investment in somebody else's hands.

How much thought do you put into choosing the new executives of your town? What do you expect these town officers to do? What does the job require? How can you elect the best person for the job if you don't know what the job requirements are? How do you interview the candidates? Do you know if the current officers are doing what they were elected to do?

We can sit back and let other people make the decisions. We can skate along blindly hoping everything takes care of itself. Or, we can become better informed and take some of the mystery out of the job of selectman.

When I became a selectman, I didn't realize the depth of the responsibilities that came with the job. Nobody does upon taking the job for the first time. However, I quickly understood the need to be motivated, informed and dedicated to both the job and the town. All this takes time. Most of it is on the job training: attending assessing classes, working with all the town committees, participating in regional issues with neighboring towns, and going to municipal workshops and conferences. Another part of the job is leadership: to uphold the integrity of the town, to

provide a direction and to forge short and long term goals. These are the things I feel are necessary to be an effective selectman.

I think the town needs to decide what is expected of the selectmen. How much time do you expect them to put into learning and doing the job? We are all busy and time is very precious, so does that mean we can say: "Just forget about it" because nobody has the time?

If only one person runs, do we automatically elect that person whether or not he or she meets the qualifications? Maybe we should take the selectman's job more seriously.

I would like to see everyone get involved. If you know somebody who would be a good candidate, even if it is you, let's encourage this person to seek the office. On a small island like ours, everybody can make a difference. I would be happy to answer any questions about the job.
