## WEST BATH LAWSUIT CLOSING

The lawsuit filed by West Bath against Arrowsic, Regional School Unit 1 (RSU1), Bath and Woolwich is formally closing. West Bath was seeking \$182,000 from our Town, claiming that Arrowsic residents unjustly benefited when RSU1 allocated the cost of its budget across municipalities between 2008 and 2012. Last summer, the judge in the case ruled that Arrowsic (and Woolwich) were not liable but allowed West Bath to proceed with the suit against RSU1 and Bath. This last December, the three remaining parties reached a settlement without proceeding to trial.

In 2013 and 2014, Town residents approved spending up to \$30,000 for our legal defense at two Special Town Meetings. Of this amount, the Town spent \$27,892.45. Our lawyer, Rufus Brown, did a very effective job at focusing his time and arguments on our Town's direct interests in the case and we appreciate his successful effort in our defense.

## THE COST OF COUNTING OUR VOTES

Everyone who participated in the tallying of votes after the last election did an important service for Arrowsic.

Counting the votes can be a bigger job than it appears. In this last election, 330 Arrowsic residents cast ballots. Three-hundred and thirty is not such a large number. What's the big deal? Tallying the votes becomes a big deal when there are several candidate races (six of them this time) plus referenda questions and bond issues (eight of them, including both state and county questions). When those are added up, each ballot had 14 different races or questions to be tallied, and suddenly it's not hundreds of votes but rather *thousands* of votes to be counted – 4620, to be exact. And that's not even including the vote for the RSU board.

Another factor that shapes the task is the required state method. For the sake of fairness, transparency, accuracy, plus ease of recounts if necessary, the state has a single method that's mandatory for all municipalities. That method has several elements (verbal, concurrent, by partisan-balanced teams, using approved tally sheets, etc.). Carefully adhering to that particular method also imposes a certain pace.

Therefore, counting the ballots takes more time, care, effort and cost than might be anticipated. Like other municipalities, Arrowsic compensates ballot counters at the rate of \$10 per hour. This past election, we spent \$280 on ballot counting, and the whole process didn't wrap up until 1:30 a.m.

There is an alternative. The state has a contract with a company that leases tabulators. Voters mark a familiar paper ballot, then feed the ballot into a scanner. After the polls close, the warden pushes a button – and the count is done. It's a significant gain in time and ease. The cost is significant also. The lease price for the tabulator, including biennial maintenance, has been \$745 per year. The state has been charging a further \$370 for programming the tabulator for each election. The contract is currently in the process of being extended through 2019; there are no more machines available at the current price and the future price isn't yet determined.

Whatever the price of the machine tabulator once the contract is renewed, it will be considerably more than the cost of compensating those who spend many hours after the polls close hand counting the votes by the required state method. Hand counting is a chore that enables us to keep the town budget lower than otherwise. Therefore, when the state recently notified us that if we didn't act now to indicate our interest in leasing a tabulator, we'd definitely be hand counting the 2016 presidential election – hand counting is what we elected to continue to do.

Voting is free: no poll tax! Counting the votes isn't. Please appreciate the hours and effort that counters put in, and consider joining us next time.

OFFICIAL TOWN SEAL**



**TOWN TO CONSIDER REPLACING THE  
MINI-PUMPER**

The Arrowsic Fire Department's Mini-Pumper is 27 years old and it is time to consider replacing it. We plan to hold our first meeting to discuss options on February 19th at 7:00pm at the Town Hall.

The Mini-Pumper plays a special role in addressing emergencies. It is smaller than our large Tank Truck so that it can handle more of the Town's winding private roads and driveways and it has four-wheel drive. It is a valued part of our mutual aid commitments to neighboring municipalities. It carries 250 gallons of water and can pump 450 gallons per minute which allows it to do much more than our Brush Truck. But after 27 years, it is wearing out, the pump is finicky and it cannot handle the pumping capacity required by current firefighting standards (1000 gallons per minute minimum).

The Select Board originally postponed considering the Fire Chief's request to replace the Mini-Pumper while we waited to hear the outcome of the West Bath lawsuit. Now that the lawsuit is closing, we believe it is time to put replacing the Mini-Pumper before the Town for consideration. At the meeting, the Fire Chief and Select Board will share information about the characteristics of a replacement truck, its cost (which could be as much as \$250,000), and different financing options. We will be interested in hearing your views on how to proceed.

**SHELLFISH CONSERVATION COMMITTEE**
