Shellfish Committee Grant proposal

Kevin Kauffunger for the Shellfish Committee, and Ruth Indrick for KELT, reported on a proposal by the Committee to request funds from the Maine Shellfish Restoration Project. The funds would assist in management of the shellfish flat by integrating data from several local groups involved in green crab trapping projects.

The Board thanked the Committee and KELT for its support of Arrowsic shellfish management and agreed to support the group's request for funding.
