## **Beginning with Habitat**

We welcomed Corinne Michaud LeBlanc, climate coordinator with the Inland Fisheries and Wildlife, to speak about Beginning with Habitat. The program is a collaboration between IF&W and some no-profit organizations. It is map-base, but they are branching out. She showed the tools available to us through a slide presentation showing areas of particular interest to BwH in our area, including mixed saltmarsh and brackish tidal marsh communities, as well as significant upland sites. She addressed our questions about vernal pools, and drinking water and aquifers. DEP runs a drinking water program; Maine Geological Survey tracks saltwater intrusion in wells, and maps subsurface aquifers; and Maine DMR has a coastal program with planners who can help communities.

The presentation ended at 7.
